Vesting Schedule	Vesting of the options shall take place as per the following schedule: <ul style="list-style-type: none"> - 0% of options shall vest at the end of a period of 1 (one) year from date of grant. - 10% of options shall vest at the end of a period of 2 (two) years from date of grant. - 20% of options shall vest at the end of a period of 3 (three) years from date of grant. - 30% of options shall vest at the end of a period of 4 (four) years from date of grant. - 40% of options shall vest at the end of a period of 5 (five) years from date of grant.
